In case Cancellation is initiated by Vandana Dental Clinic due to unavailability of doctor or **if doctor is unable to attend** patient after Pre-Screening at Clinic.

• 100% of Consultation Fees will be refunded. However, **please note that convenience fees** will not be refunded.

At the time of cancellation, amount will be refunded via same source of payment and will be subject to the payment terms of the source only. Amount will be refunded within 7 working days. It may take 7-21 days to reflect in user account depending on user bank/card used.
